16-1 SOCIO-ECONOMIC, HEALTH AND POLITICAL CONDITION OF PEOPLE

In general, even in the twenty first century, there has been the weaker section all over the India, specifically in Tamilnadu State Now, both State and Central Government have mitigated the sufferings of poor and needy in some extent being implemented many kinds of welfare schemes.

What have we done for our nation so far on our part? – To this question, we must be subjected to the prime and unique contexts of integrity, solidarity and fraternity which means that there should be our co-ordination with Non-Governmental voluntary organizations registered under the democratic set up act as per our Indian constitution.

If so, each and every individual can have power to eradicate the following issues inappropriate to a good society and find a solution on a proper manner towards success in all respects

- i. Illicit arrack in a certain area is sold on a hidden way violating the dream of our national father Mahatma Gandhiji. Many are likely to be suffered a lot thereof. Preventive measure thereto is immediately needed.
- ii. Even the cultivated men and educated youth are consuming alcoholic drinks to have the intoxicating mood always. Now-a-days, many people have become as alcoholically addicted – They are to be given up such bad habit which has been intolerable and unbearable in a family circle and to be repented.
- iii. At Present, Kattumannarkoil Taluk has the 75 percent of literates proportionately. In spite of it, due to unemployment problems, youth are leading a random life. Fortunately, a hundred days employment scheme helps poor youth and old aged people to survive for their livelihood.
- iv. A pitiable situation has, now arisen that all the cultivable lands situated beside main roads are changed as flats for sale. Trees are cut off. Most Probably, there will be no cultivation of paddy in future.
- v. The biggest lake named “Veeranam” and collroom in a broad manner have been in our area but there is no benefit for the farmers because it would not help for the irrigation purpose.
- vi. Due to evil of lust, dominant Group / Elite people are cheating disadvantaged and weaker sectional women having sexual intercourse with them. Poly gamy sexual practice is prevalent in our area. Consequently, Numerically counted HIV/AIDS patients are under treatment confidentially.
- vii. Discrimination between high caste and out caste is still existing. Communal clashes occur thereof then and there.
- viii. Due to the polluted masses, people including children are very much suffered for want of emergency hospital nearby for the treatment.

- ix. There has been unbearable situation that elders in their disabled condition are driven out from home and are illtreated by their legal heirs and daughter-in-laws.
- x. In the light of global warming and new climate change, monsoon is differed and changed and so the day to day life style of human being and sustainable & unsustainable cultivation is fluctuated.
- xi. Literates and illiterates have the voting rights, Nevertheless, they are threatened while franchising their votes – This kind of violation and aggression is hold in the weaker sectional community only.
- xii. As there is non-availability of protected drinking water and good environment, people are suffered a lot and they become a healthily weakened consuming contaminated or muddy water.

17-1 GEOGRAPHICAL

The entire area of Cuddalore District, specifically Kattumannarkoil has become as a drought prone area as promulgated by the former and present chief minister of Tamilnadu State Puratchi Thalaivi, J. Jeyalalitha. The particular area where the V.P.Trust organization is situated, has an unique lake called as Veeranam which helps metropolitan city people of Chennai through giving protected drinking water.

Besides, a broaded collroom river helps people in both ways of irrigation and drinking water. Above and all, it is called as an holy land. Yes!, In and around of Kattumannarkoil Taluk, there have been many denominational churches, mosques and temples –
